I personally believe that Museveni is above the laws, he treats Uganda as his personal property, he never stops to misbehave, therefore by the words of Pastor Patience: Money corrupts, you loose morals in addition, ethics has happened before our eyes.

A Month ago 2009 Mr. Bassajabala, who owns a private Kampala International University received free Government money- Shs 4billion, yet four Government Universities were given Shs 500million, each, 1/8 of what was given to **private-** Kampala International university, yet in the same period, Makerere University lucked funds and had rised up tuition, which did not sit well with the students and were planning to demonstrate against such high coasts, this picture is troubling.

The Opposition parties all along have complained to IGG to force NRM Party to release records of their campaign funding, for they have been accused of stealing tax payers money, which they do.

Since **they are the NATIONAL ROBBERY MOVEMENT (NRM)** Funding Bassajabala's private university Shs 4billion was **a scheme to get money out of the treasure account into NRM PARTY account** without causing any uproar, you people did not fool anyone but yourselves, once again you proved the kind of National robbery movement (NRM) which you are, In USA we call that money **laundering.**

4. President Museveni's government has been ranked no.3 most corrupt government in the whole world by the **world bank and no.1** in East Africa, such statement I have personally asked many Ugandans

who have gone home for Christmas, and overwhelmingly state that everyone in Uganda is corrupt.

The bar of morality has been pulled down so low, it is now part of a collective psyche to believe one cannot prosper without stealing.

Facts: Uganda's public procurement and Disposal of the public Assets Authority (PPDA) estimates that over US \$184Million is lost every year to corruption.

Uganda Debt Network puts the amount lost to corruption at US\$108Million Annually.

Transparency international's Uganda Chapter believes that most of the Government funds are lost to corruption. That figure that would total a staggering (US\$950million)

In 2004, the Geneva-based Global Fund awarded Uganda- US \$367 Million in grants over two years to fight aids, tuberculosis in addition, malaria, intended to strengthen health systems and pay for diagnostics, mosquito nets and other necessities. But in August 2005, an audit by price water house cooper **found management regulates serious enough to prompt the Global fund management to suspend the grants.**

The finance minister then Dr.Ezra Suruma announced during his 2007/08 budget speech that the USA government had granted Uganda \$10.2 millions (more than shs 18 billion) to strengthen "investigation, documentation and prosecution of **-corruption cases,**" **which M7 does selectively going after small fish, his enemies-opposition leaving out the big fish his henchmen/mafias that have bankrupted the nation.**

In 2007/2008 Shs 960 million allocated by the parliament meant for investigation the people implicated in the embezzlement of money from the Global Fund for AIDS, tuberculosis and malaria, **disappeared from Bank of Uganda no tress of it.**

Fellow Ugandans I think this explains why hospitals are in shambles.

- Now, in 2009, SHS.100 billion met for **North Uganda social fund (NUSAF) is unaccounted for, NRM Government is playing' "catch me if you can" movie.**

President lost Credibility long time ago, In 2006 he promised the Nation that he was going to fight corruption even in his NRM party. If we are real true to our faith, we should take some lessons from Prophet Moses described in the book of Hebrews 11:24-27, By faith Moses when he was grown up; he refused to be called the **son of Pharaoh's daughter**, choosing rather to share ill-treatment with the people of God than to **enjoy the fleeting pleasure of sin**. He considered abuse suffered for the Christ greater wealth than the treasures of Egypt, for he looked to the reward, by faith he **left Egypt**, not-being afraid of the anger of the King; for he endured as seeing him who is invisible....

Who is this brother speaking tough words to us? 'Who does not see alternatively, acknowledge our accomplishments, you may ask; I am a fellow servant of God under the holy spirit ministry, as an Evangelist and Prophet.

In the Name of Jesus Christ, I rebuke you in love, reminding you of the words of Jesus and those, through Apostle Paul.

God shows personal favoritism to no man. He picked Gideon who came from the most Small and despised Clan, and in his Clan, his family was the least of all and in his family he was the least. will I declare to them,' I never knew you; depart from me, you evildoers.

Apostle Paul understood this statement by Jesus Christ. Furthermore, he understood the difference between **ministry and personal walk by faith in Jesus Christ**; hereby stating - In 1Corinthians9:27-.....**but I Pommel my body and subdue it, lest after preaching to others, I myself should be disqualified.**

Despite the fact that we have a better Covenant than that given to Moses, but none of you and me have accomplished what Prophet Moses accomplished, talking about accomplishments; aha! But he was not Judged based on his accomplishments/ ministry but as a person minus ministry? The rest of the story was; he was disqualified to lead the Children of Israel into the promised land despite of all his dedication to guild and teach tirelessly the Israelites in the wilderness. He who has ears to hear the Spirit of the Lord let him hear.
